

## Trainees get their teeth into new employment program

A new Brotherhood employment program is giving 16 young people opportunities in dental health. The STEP program (Scheme for Training and Educating People) at the Brotherhood's Employment Action Centre in Fitzroy is giving participants 12 weeks pre-vocational training before their employment as trainees at the Royal Dental Hospital, and the East Bentleigh and North Richmond Community Health Centres. At the completion of their one-year traineeship, these young people will qualify as Dental Assistants with the option to continue with their education or seek further employment in the dental field.

The trainees, who come from a variety of cultural backgrounds, will be using their skills in languages other than English to good use in the community settings of their host employers. The trainees will be learning on the job, while helping non-English-speaking dental clients in potentially confusing or stressful situations.

It is the first time that the STEP program (funded by the Office of Training and Further Education and Group Training Australia) has specifically targeted unemployed young people from non-English-speaking backgrounds to participate in a traineeship program and the first program to have been developed in partnership with the dental industry.
